The Five Freedoms of Animal Welfare, developed by the Farm Animal Welfare Council (FAWC), serve as a global guideline for ethical livestock management:

- 1) Freedom from hunger and thirst
- 2) Freedom from discomfort
- 3) Freedom from pain, injury, or disease
- 4) Freedom to express normal behaviour
- 5) Freedom from fear and distress





However, large-scale industrial farming or 'factory farming' has often been criticized for confining animals in minimal spaces, overusing antibiotics, and prioritizing profit over welfare. Such practices not only cause physical and psychological stress to animals but also pose risks to public health through the development of antibiotic-resistant bacteria. (Friedmann, 2021)

Transportation and Handling

Transportation is a very critical phase where animals are highly susceptible to stress, injury, and even death. Overcrowded transport, lack of ventilation, prolonged travel without rest or water, and rough handling are common issues (Nielsen *et.al.*, 2010). Ethical transportation practices include:

- Decrease transportation time, cover short distances
- Use a proper Vehicles: Vehicle should properly ventilated, non-slippery and not overcrowded.
- Providing adequate ventilation
- Ensuring proper loading and unloading techniques
- Training handlers in humane treatment: Workers must be trained to load and unload animals calmly and without forces. (Amos *et.al.*,2018)

In many countries, legal frameworks exist to regulate animal transport, but enforcement remains a challenge, especially in developing nations.

Slaughter and Processing

The ethical dimension follows in slaughterhouses where animals should be handled with care and killed in the most humane way possible. Pre-slaughter stunning, which renders animals' unconscious before killing, is a recommended practice and is mandated in several regions. However, religious, and cultural practices such as Halal and Kosher slaughter may pose variations in ethical norms. Proper facility design, trained personnel, and regular inspection are essential for upholding humane slaughter standards (Cockram, 2017).

- Pre-slaughter stunning: Slaughtering of animal by stunning is a humane method of slaughtering, in this method animal is unconscious before slaughter to prevent the pain.
- Follow hygienic standards and legal regulation.

• Ethical supervision: Presence of veterinarian during the ante-mortem examination and compare with welfare laws

Additionally, animal welfare at this stage directly influences meat quality. High levels of stress can lead to conditions like PSE (pale, soft, exudative) meat in pigs, decrease the pH of meat or DFD (dark, firm, dry) meat in cattle, which are less desirable and causes economic losses.

Ethical treatment does not end at the slaughterhouse-it also depends on consumer choices and it is also very impactful in our ethical way of animal treatment.
